4. It will appoint only qualified staff to teach Classes XI & XII as per requirements laid down by the Board.
5. It will provide for adequate co-curricular and extra-curricular activities for the wholesome development of the students.
6. It will abide itself by the Affiliation Bye Laws of the Board and other rules and regulations prescribed by the Board from time to time.



Aided/Sainik/Railway/Atomic Energy etc. are granted regular affiliation and these schools have been advised to remit prescribed annual fee through link provided on Board website [www.cbseaff.nic.in](http://www.cbseaff.nic.in) under the Government Schools Corner.
9. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidate.
10. The school is required to submit the request for change of school address through the Competent Authority of the school i.e. Assistant/Deputy Commissioner, Kendriya Vidyalaya Sangathan of their region.
11. Special conditions to be complied within 01 month:-
  - i) The school is required to appoint Special Educator as per rule 13(11) of Affiliation Bye Laws of the Board and as mentioned in Board circular dated 25/06/2015.
